Everything we offer is open to everyone without discrimination based on gender, race, religion, nationality and / or origin. According to our statutes and our obligations to our students, the following few rules apply:

- 1. The attached form must be completed and signed then sent to the above address or by email accompanied by payment, at least one week prior to the start of the 1st Class.
- 2. Payments are made by check, by cash, by Venmo or by paypal
- 3. A group session must include a minimum of 4 students and a maximum of 8. Below 4 participants, the session will be canceled.
- 4. Any scheduled session is due in its entirety. AFF does not prorate its courses.
- 5. In order to be reimbursed, a student must withdraw from a paid session at least 3 days before the start of the first lesson.
- 6. If AFF must cancel a course for lack of teacher or for any other reason beyond its control, this course will either be postponed or reimbursed.
- 7. In case of absence, scheduled or not, for a lesson, the student must notify the teacher.
- 8. Private lessons are not refundable in case of cancellation by the student.
- 9. Private lessons must be taken within 6 months from the day of payment.
- 10. According to AFF bylaws, students are not considered full members but are encouraged to become members in order to support the association and benefit from preferential rates on all services, events and activities organized by AFF.
- 11. AFF reserves the right to dismiss disruptive students based on complaints that may arise from the teachers or from other students.
